CHARGES

- Will be those applicable from the 1st of January of the year of use of the facility rather than those applicable at the time of booking.
- Will be for the **WHOLE** of the period booked even if you vacate the Slipway earlier than anticipated. Normal slippage day is Sunday of each week but it might be possible to arrange a lesser period than Sunday to Sunday. (Please contact the Club office or the Bosun.)
- 2011/12 Rates are: -£65 for Slippage (Total both ways) with **Free Use** in between slippage days inclusive of VAT in any one calendar year. Thereafter the Daily Rate will be £10.
- The hire fee will be due immediately after your use of the facility but if it is your wish you may pay the Honorary Treasurer at any time in advance.
- 50% of the total fee which would have been due will be required in the event of the booking being cancelled within 7 days of the start date, as it may not be possible to re-let the booked period.
- All cheques are to be made payable to Stafford Boat Club Ltd. Card payments may be made via the Club office either in person or by telephone. (01785 660725) (Not always manned).

GENERAL CONDITIONS and INFORMATION

1. Stafford Boat Club Ltd will make every effort to ensure that the Slipway is available for the days you request but very occasionally, due to unforeseen circumstances, there may be a 24 hour delay. Should this occur there will not be a charge for the period of the delay.
2. If for any reason you need to utilise the facility for a longer period than that booked, please discuss this with the Club office, or the Bosun, as soon as possible, as someone else may have booked the facility.
3. **Whilst undertaking your work we require that you and/or any contractor that you employ should abide by the following rules /guidelines.**
 - a) 3rd Party Indemnity Insurance for your boat of at least £2,000,000 should be in place and a photocopy of the Insurance Certificate should already be in the possession of the Club Honorary Secretary.
 - b) As the Club is situated in a residential area, users of the Slipway are asked to have consideration for our neighbours. **Acceptable times for working where noise is involved (eg:-pressure washing or grinding) are 10.00am to 5.00pm at weekends and 9.00am to 6.00pm on weekdays.**
 - c) Sand or Grit Blasting is NOT ALLOWED.
 - d) Only ELECTRIC pressure washers may be used to wash off boats. The Club may have one available for use. Please ask if you wish to avail yourself of this equipment.
 - e) At all times you must keep the area around your boat safe and tidy.
 - f) **At the end of your time on the facility PLEASE ENSURE THAT THE TRACK AND THE SURROUNDING AREA ARE LEFT CLEAN, TIDY AND READY FOR THE NEXT USER.**
A rubbish bin is provided on the hard standing. Only metal items should be deposited in the adjacent skip.
 - g) Please take care when handling paint and oil etc., and immediately clean up any accidental spills.
 - h) Similarly to when moored at the Club you must comply with the Bosun's Rules, a copy of which is available to view in the winch house on site.

INDEMNITY

On using the Slipway at Stafford Boat Club, I (and any contractors undertaking work on my boat) accept that I will indemnify Stafford Boat Club Ltd and owners of other boats/vehicles/machinery for any loss or damage howsoever caused whilst I (or my contractor) undertake work on my boat, details of which are overleaf.

I agree to abide with all the contents of this Application and Agreement Form and confirm that the Club Honorary Secretary holds a copy of my current 3rd Party Indemnity Insurance.
